




## UNIVERSITY CROSSING TRAIL VOLUNTEER IN PATROL (VIP) BIKE PATROL

- Program Background: The Dallas Police Department (DPD) manages a city-wide Volunteer in Patrol (VIP) Program
  - Through the VIP Program DPD trains neighborhood volunteers to Observe & Report suspicious activity in their communities
  - VIP Results Where the VIP program has been deployed, DPD has seen a reduction in crime
- **University Crossing Trail (VIP Bike Patrol):** This program is a partnership between DPD, the UCPID, and Mockingbird Station. Each party brings something unique to the partnership:
  - DPD trains volunteers in the VIP Program and only those certified in the program can participate in the VIP Patrol
  - The UCPID has purchased two (2) bikes, with accompanying equipment, for use in the VIP Bike Patrol
  - Mockingbird Station has agreed to store the bikes on their premises, which allows volunteers easy access to the trail

**Next Steps:** The UCPID is looking for volunteers to join this program! The more volunteers we have the more successful this program will be!

### **HOMELESS OUTREACH PROGRAM**

- Every Monday & Tuesday The UCPID's Homeless Outreach Team deploys in our community with the goal of helping the homeless transition to shelters and other supportive housing
- The Homeless Outreach team consists of the following:
  - Homeless Case Manager trained in assisting the homeless community
  - **Executive Security Escort** the security escort who helps ensure her safety
- In addition to funding the Homeless Outreach Team The UCPID purchases supplies the team can use to assist with their outreach
  - Water, bus passes, etc.

# UNIVERSITY CROSSING

2021 – 2022 CAPITAL IMPROVEMENT PROJECTS

## PEDESTRIAN LIGHTING (UNIVERSITY CROSSING TRAIL)

- In the fall of 2021 TXDOT approved the Environmental Study for this project.
- In the spring of 2022 The UCPID submitted its Construction Document for final approval from TXDOT.
- The Construction Document calls for the following:
  - Light Fixtures from Glencoe Park (near Martel) to Twin Sixties Dr.
  - Light Fixtures from the "Red Line" Bridge, above the DART line, heading east to the Greenville Ave. & Matilda Bridges
  - From Matilda Bridge to Skillman (Phase 1 Completed): Oncor has installed light fixtures on existing light poles, located along the trail (NOTE: Oncor installed these light fixtures at NO COST, and the City of Dallas is paying the electricity cost. The UCPID thanks Oncor for this generous service!)
  - Estimated Cost of Project: \$1,000,000

### THE UNIVERSITY CROSSING TRAIL PEDESTRIAN LIGHTING PROJECT (FUNDING)

- Now that the relevant contracts are approved, including the UCPID's Funding Agreement, the project can move forward!
  - **Background:** In 2017 The North Texas Council of Governments (NTCOG) awarded the City of Dallas and the UCPID a reimbursement grant to fund pedestrian lighting along the *University Crossing Trail (Note: Under the Funding Agreement, the UCPID will fund approximately 20% of this project, which is approximately \$300,000. Additionally, the UCPID will fund certain cost overruns, but the cost has been "capped" at \$750,000. If there are overruns beyond the "capped" amount, with Board approval the UCPID may provide additional funding).*
  - **Background:** The UCPID partnered with Dallas Park & Rec. to develop a **Funding Agreement** to install the pedestrian lighting
  - **Background:** In 2018 The UCPID met with TXDOT, Park & Rec., and other Community Stakeholder to discuss implementation
- Next Steps: In 2022 TXDOT will approve the *Construction Document*. With TXDOT's approval, Park & Rec. will select a contractor to install pedestrian lighting along the trail. The UCPID will push for installation of the lighting in the winter of 2022 2023, and the UCPID will carry forward funding to ensure completion!








### UNIVERSITY CROSSING TRAIL (REST AREA)





# **DECORATIVE FENCE** (DESIGN CONCEPT)


There are many aperture types the vertical slotted "Horse" fencing would be difficult to climb. I would recommend a "farm type" fencing company be involved in the putting it up.




Above. A single set could be used. Below. A double set with a gap in between could be installed.

- Next Steps: Enjoy the trail!






#### NEW SCULPTURE & REST AREA (ON UNIVERSITY CROSSING TRAIL NEAR PREMIER PLACE)

- In 2022 The UCPID is proud to partner with community stakeholders to install a new Sculpture & Rest Area along the University Crossing Trail.
- This project would not be possible without a partnership between the UCPID, Mockingbird Station, and Premier Place. Each partner brings something unique to this project:
  - Mockingbird Station has generously donated a sculpture, for public use along the University Crossing Trail.
  - Premier Place has generously donated the land for the new Sculpture and Rest Area, which sits next the University Crossing Trail.
  - The UCPID is funding the restoration and installation of the Sculpture and the new Rest Area.






### **REPAINTING PEDESTRIAN CROSSWALKS**

- To promote pedestrian safety The UCPID will repaint three Pedestrian Crosswalks in our community
- The Intersections include:
  - Greenville Ave. & Milton St.
  - Greenville Ave. & University
  - Greenville Ave. & SMU Blvd.
- These intersections were chosen because of the high pedestrian traffic.
- **Next Steps:** The UCPID will continue to monitor crosswalks in our community to help ensure pedestrian safety!

### **MOCKINGBIRD PEDESTRIAN & BICYCLE STUDY**

- In May 2022 The UCPID met with representatives from the City of Dallas, Transportation Dept. where the City confirmed its plans to move forward with improvements outlined in this study.
  - Background: Under the City of Dallas' 2017 Bond Package Improvements outlined in the Mockingbird Pedestrian & Bicycle Study are designated for funding. (Note: The improvements are found in the "US75/Mockingbird/Lovers Lane Pedestrian Improvements")
  - **Background:** In addition to the City of Dallas, TXDOT and the NCTCOG have also pledged to help fund these improvements.
  - **Background:** TXDOT has already begun implementing improvements from the *Mockingbird Pedestrian & Bicycle Study* (TXDOT's improvements can be found at the intersection of Mockingbird Ln. & US75, in the form of new pedestrian crossings!)
- Next Steps: In 2022 The UCPID will partner with the City of Dallas to develop a Funding Agreement, which will focus on widening and beautifying the sidewalks along Mockingbird Ln, between US75 and Matilda St.

#### **GREENVILLE AVENUE & KATY TRAIL ENHANCEMENT MASTER PLANS**

- In 2022– The UCPID met with representatives from the City of Dallas, Transportation Dept. where the UCPID shared the *Greenville Avenue & Katy Trail Enhancement Master Plans* ("Greenville Ave. Plan"), to implement the improvements outlined in the plan.
  - Background: In 2016 The UCPID commissioned the Greenville Ave. Plan, developed by Jacobs Consulting
  - **Background:** The Plan outlines numerous capital improvements along Greenville Ave., including upgraded sidewalks, additional street lighting, generous tree planting, and beautification to the medians on Greenville Ave.
  - **Background:** The UCPID used the Greenville Ave. Plan to develop the pedestrian lighting along the trail. Now, the UCPID plans to implement additional recommendations from the Greenville Ave. Plan, with emphasis on improved sidewalks.
- Next Steps: In 2022- The UCPID will partner with the City of Dallas to develop a Funding Agreement, which will focus on widening and beautifying the sidewalks along Greenville Ave., between SMU Blvd. & Lovers Ln. Additionally, the UCPID will focus on beautifying the medians, on Greenville Ave., between SMU Blvd. & Lovers. Ln.

#### **PEDESTRIAN "FLASHERS"**

- The UCPID has identified at least two locations where pedestrian "flashers" would help protect our community. The locations are as follows:
  - Twin Sixties Dr. & the University Crossing Trail (UCT)
  - Worcola St. & the University Crossing Trail (UCT)
- Next Steps: The UCPID has notified the City of Dallas, Park & Rec. Dept. ("Park & Rec.") about our concerns, and the Park & Rec. should be developing a plan. If additional funding is required, the UCPID is happy to discuss funding assistance.

# UNIVERSITY CROSSING

2021 – 2022 MAINTENANCE PROGRAMS

### MAINTENANCE PLAN (MOCKINGBIRD LANE)

- The UCPID contracts with the landscape company, Green2B, to maintain Mockingbird Lane (Maintenance starts west of US75 (near the CVS) and continues east to Matilda)
  - In 2022 The UCPID replanted the planters with purple sage & yellow lantana to beautify the streetscape
- Green2B also maintains portions of the US75 Access Road Along southbound US75 near Mockingbird Lane
- **Repainting Planters:** In 2022, the UCPID plans to repaint six planters on Mockingbird Lane, between Mockingbird Station & Matilda Ave.
- Next Steps: We plan to continue this Maintenance Plan but welcome any feedback or suggestions

#### MAINTENANCE PLAN (SMU BLVD.)

- The UCPID maintains portions of SMU Blvd. (Maintenance is between US75 & the DART track)
- We keep SMU Blvd. free from trash and debris and maintain portions of the landscaping – which includes the southside of the sidewalk and the medians
- **Next Steps:** We plan to continue this Maintenance Plan but welcome any feedback or suggestions



# MAINTENANCE PLAN (UNIVERSITY CROSSING TRAIL)


- The UCPID maintains a portion of the University Crossing Trail (UCT) (Maintenance is from SMU Blvd. to Twin Sixties Dr.)
- UCPID keeps the UCT free from trash and debris and maintains the landscaping – which includes Spanish Grass
  - The UCPID funds a Porter Service that removes trash and debris from both SMU Blvd. & the UCT.
- **Next Steps:** We plan to continue this Maintenance Plan but welcome any feedback or suggestions.



#### MAINTENANCE PLAN (UNIVERSITY CROSSING TRAIL – PEDESTRIAN LIGHTING)

- The UCPID maintains the light fixtures along the UCT, from SMU Blvd. to the "Red Line" Bridge. (Note: This includes 11 light fixtures).
- The UCPID pays the electricity for these 11 light fixtures and provides maintenance when required. (Note: After assuming responsibility for these light fixtures The UCPID is now able to ensure this portion of the UCT is illumined).
  - A special acknowledgement to UCPID Board Member, Larry Walton, for walking the trail to monitor these lights!
- Next Steps: Enjoy the lighting!




### MAINTENANCE PLAN (US75 ACCESS ROAD)

- The UCPID maintains a portion of the US75 Access Road (Maintenance is on the southbound side of US75 near Mockingbird Lane)
- We keep the Access Road free from trash and debris and maintain the landscaping
- **Next Steps:** We plan to continue this Maintenance Plan but welcome any feedback or suggestions

#### **PUBLIC TRASH RECEPTACLES**

- After installing public trash receptacles along Mockingbird Ln., SMU Blvd., and University – The UCPID maintains the receptacles to encourage a "culture of clean" in our community.
- Every week these trash receptacles our emptied by the UCPID's maintenance team, Green2B, and in the event a receptacle is damaged, the UCPID will replace it.

# MAINTENANCE (THROUGH COMMUNITY ADVOCACY)

- In addition to funding Maintenance Programs The UCPID also acts as an advocate for our community!
- This year, the UCPID partnered with DART and the City of Dallas to clean homeless encampments in our community. (**Note:** The area of focus is US75 & Lovers Ln.)
  - Specifically, under Councilmember Paul Ridley's leadership, the City of Dallas and the UCPID have developed a partnership to install fencing on the southeast corner of Lovers Ln. & US75. Under this partnership, the City of Dallas will install a chain link fence, and then the UCPID will upgrade the fence into an art installation, similar to the Art Fence under the Greenville Ave. & Matilda St. bridges.
  - Additionally, the UCPID has offered to install landscaping along Lovers Ln., which would both beautify the area and deter the homeless from congregating in the area.

- Next Steps: Access the UCPID's website at <u>www.universitycrossing.com</u> and get a glimpse of our vibrant community!



#### **GOALS FOR 2022 - 2023**

- **Support Public Safety:** Utilizing our ENP Program, with an emphasis on community engagement and proactive policing, the UCPID will enhance the safety of our community.
- **Support Public Safety:** Utilizing our Homeless Outreach program, the UCPID will enhance the safety of our community through compassionate outreach to the homeless.
- Support Capital Improvements: With an emphasis on pedestrian safety The UCPID will finish the <u>Pedestrian Lighting Project, along</u> <u>the University Crossing Trail</u>, partner with the City of Dallas on the <u>Mockingbird Pedestrian & Bicycle Improvements</u>, and implement projects from our <u>Greenville Avenue & Katv Trail Enhancement Master Plans</u>
  - **Carryforward Funds:** Using the \$1,800,000 allocated to the *University Crossing Trail Lighting Project*, in the 2022 Service Plan, in 2022 and 2023 the UCPID will complete installation of trail lighting. *In 2023, remaining carryforward funds will be used to fund the Mockingbird Pedestrian & Bicycle Improvements, the Greenville Avenue & Katy Trail Enhancements Master Plans, and other important improvements like a Dog Park or police Store Front.*
- Support Maintenance Programs: Enhance the quality of life of our community through vigilant maintenance
- Promote our Community: Highlight local businesses on the web and through social media
- **Promote the Arts:** To strengthen community identity and engagement by continuing to support the arts through such programs like the UCPID's public art initiatives.
