


UNIVERSITY CROSSING

SAFETY TIPS

WHEN TO CALL 911? CALL THE POLICE IF YOU:

- -Are in physical danger
- -See or smell fire
- -Hear a fight or domestic dispute
- -Hear screaming or call for help
- -Hear gunfire

- -See an endangered child
- -Hear an alarm or suspicious sound
- -Witness a mentally unstable person
- -Health emergency

If you SEE SOMETHING, you should SAY SOMETHING!

PEDESTRIAN AND BICYCLE SAFETY

University Crossing is dedicated to making our neighborhood a wonderful place to walk, bike and use mass transit. Our goal is to make sure the neighborhood is a safe place for pedestrians and bicyclists. Here are some tips on how to walk safely through the PID.

PEDESTRIAN SAFETY TIPS

- -Cross in crosswalks at intersections
- -Cross streets and driveways in front of vehicles—never behind them!
- -Look both ways before crossing a street
- -At signalized intersections, cross only when the signal indicates it is safe
- -Watch for vehicles and try to stay out of blind spots when possible
- -Make eye contact with drivers before crossing streets
- -Be seen while walking in the dark
- -When there is a sidewalk, use it!

BICYCLE SAFETY TIPS

- -Bicyclists are required to stop and yield at traffic signals and stop signs
- -Use hand signals to let others know when you're turning, changing lanes, etc.
- -Always ride in the same direction as traffic
- -Ride as far to the right as practicable
- -Wear a properly fitted helmet to reduce the chances of injury

HOW TO: GET A CRIMINAL TRESPASS AFFIDAVIT

The Criminal Trespass Affidavit (CTA)
Program allows property owners, or
persons responsible for the property, and
the Dallas Police Department to work
together to reduce criminal activity on
private property.

HOW A CTA WORKS:

- -The Dallas Police Department is authorized by the property owners or manager to remove or arrest persons found on the property when they are not authorized.
- -An individual arrested for trespassing will be charged with a violation of the Texas Penal Code, Sec. 30.05, also known as Criminal Trespass.
- -The property owner or manager will be the person formally filing the criminal complaint against the violator(s).
- -The property must have approved signage posted.

WHAT HAPPENS WHEN A SUSPECT IS CRIMINALLY TRESPASSED?

If a property owner or manager criminally trespasses a suspect, a police officer will provide a Yellow Criminal Trespass (CT) Card.

This card is necessary to proceed with charges if the suspect returns and violates the CT.

HOW DO I OBTAIN A CTA?

To obtain a CTA, contact the Neighborhood Patrol Officer (NPO) in the Patrol Division where your property or place of business is located. The CTA coordinator will follow up with property owners or managers for renewal once the CTA on file expires.

HOW LONG IS IT VALID?

- -A CTA is valid for 60 days without a suspect photograph.
- -A CTA is valid for 120 days with a suspect photograph.

WHO FROM DPD SERVES YOU? WHY DOES IT MATTER?

The University Crossing Community sits inside two separate Dallas Patrol Divisions: the Central Patrol Division and the Northeast Patrol Division. Depending on the location of your home, property, or place of business, you may have a different police contact from your neighbor. To determine which patrol division serves your home, property, or place of business, refer to the map on the second page.

-Central Patrol Division: If your home, property, or place of business is located within the pink, blue, or yellow area, it is in the Central Patrol Division.

-Northeast Patrol Division: If your home, property, or place of business is located in the green area, it is in the Northeast Patrol Division.

Regardless of your Patrol Division, you should know and develop a relationship with your Neighborhood Patrol Officer (NPO). Your NPO is your key to DPD information and re-sources.

CODE COMPLIANCE TIPS

Code Compliance Tips

Check out the tips below on how to avoid a code compliance violation.

Exterior/Parking Lots

-Regularly check and maintain your property to ensure it complies with all relevant Dallas City Code fire, health, safety, and building provisions.

-On the exterior of your property, pay close attention to lights, signs, fences or screening. These are the first things Code will look for when they drive up.

- -Look for rotted or exposed wood.
- -All off-street parking areas must be lighted.

-Report public street light outages around your property to Oncor by calling 1-888-313-4747 or using their on-line outage reporting system at https://www.oncorstreetlight.com/.

- -Ensure your property address is clearly visible, and you have signs for each unit building and cross drives.
- -Make sure all litter is picked up and the common areas are free from debris.
- -Replace broken windows and secure open and vacant units.
- -Parking lot stripes must be clear and visible Lock, Take, and Hide signs posted (one for every 50 parking spaces).

CRIME WATCH AND SAFETY TIPS

The University Crossing PID employs an Extra Neighborhood Patrol (ENP) through the Dallas Police Department to ensure the University Crossing neighborhood is safe and secure. In 2016, the UCPID helped to reduce crime in our neighborhood by 19 percent.

HERE ARE SOME TIPS TO HELP KEEP OUR NEIGHBORHOOD SAFE

-Call 911 to report emergencies and immediate suspicious activity.

-Utilize iWatch Dallas to report suspicious activity, while remaining anonymous. Call 214-671-4TIP, or Text "DPD" plus your tip to 274637, or download the free app.

-Institute an Operation ID program in your community to deter theft. Operation ID encourages residents to mark the property with their driver's license numbers, keep an inventory of property and display Operation ID decals on windows.

-Execute a Criminal Trespass Affidavit (CTA) so DPD can remove trespassers from your property. If you have not done this, contact the Central (214-670-7747) or Northeast (214-670-4420) Police Divisions depending on the location of your property.

-Monitor police incidents and 911 calls in your community by visiting www.dallaspolice.net and inputting your property address. We can provide training on the public search or other online tools—just ask!
